



#### From the DCMC

When I first became a GSR, discussions were just starting about whether or not AA should publish a fourth edition of the <u>Big Book</u>. Years later, when it was published, we reached another milestone in AA history and I had a glimpse of Concept I, which says: "The AA groups today hold ultimate responsibility and final authority for our World Services." We actually had an active role in deciding if there would be a fourth edition, and what changes, if any, should be made.

At the October and November meetings of Suffolk General Service, we may have seen the beginnings of another AA milestone. The informed group conscience decided that there is a need for a conference-approved pamphlet on the place and role in AA of Intergroups/Central Offices.

Does that mean there will be such a pamphlet? Not necessarily, but if a widespread need is expressed, it's a good possibility. So what happens next?

As the Chair of General Service in Suffolk County, I have been asked to bring the request to our Area Assembly (Suffolk is part of Southeast New York [SENY] Area 49, which is made up of twelve counties and one non-geographic Spanish District). If approved in the Assembly, our Delegate Bill C. can represent the area level approval to the Conference. The process would go through the General Service Office, the Trustees Literature Committee, the Conference Literature Committee, and eventually the full Conference.

It's a long process but that's a good thing. It's no secret that we alkies are not particularly fond of change. Besides, moving slowly also allows a chance for everyone's voice to be heard, helps weed out a lot of mistakes, and ensures that the final decision will be in harmony with group conscience of the entire fellowship.—Ed C.

Be host to A.A. friends, especially newcomers. If you don't have a place where you can throw a formal party, take one person to a diner and spring for the coffee.



Keep your A.A. telephone list with you all the time. If a drinking urge or panic comes—postpone everything else until you've called an A.A.



Find out about the special holiday parties, meetings, or other celebrations

given by groups in your area, and go. If you're timid, take someone newer than you are.



Skip any drinking occasion you are nervous about. Remember how clever you were at excuses when drinking? Now put the talent to good use. No office party is as important as saving your life.



If you have to go to a drinking party and can't take an A.A. with you, keep some candy handy.



Don't think you have to stay late. Plan in advance an "important date" you have to keep.



Worship in your own way.



Don't sit around brooding. Catch up on those books, museums, walks, and letters.



Don't start now getting worked up about all those holiday temptations. Remember— "one day at a time."



Enjoy the true beauty of holiday love and joy. Maybe you cannot give material gifts—but this year, you can give love.

#### SIA Meeting Minutes for December 13, 2005

**Brian C.** opened the meeting at 8:07 PM. Jim from Longwood Love and Service read the 12<sup>th</sup> Tradition and Tim from Bohemia Together read the 12<sup>th</sup> Concept.

5 new SIA representatives introduced themselves and were encouraged to attend the "New Representative Orientation Meeting". Held at 7:00 PM preceding the monthly SIA meeting, which next month will be in Riverhead.

**Recording Secretary** – Tracey was absent. No minutes were available, but they were sent out with the Bulletins to each group last month.

Treasury – Fred explained the 2 budgets distributed. One reflected the monthly report and Fred pointed out that we are down \$3000 (-6%) in contributions. The other report he explained later.

Phones – Hotline coverage is needed all day Thursday (12/15/2005) and the 8:00 Pm shift on Friday (12/16/2005). Anyone able to fill these commitments should see Don at the end of the meeting.

Brian announced that we have been able to get a one-year extension on our lease. The landlord has agreed to replace one door and make some other repairs. We no longer need to shop for a new office.

Brian also talked about the By-Laws ad hoc committee that formed 2 years ago to review the SIA By-LAWS. Now that the 2 years have passed, recommendations have been made and they can be voted on next month.

Phones – Dave thanked those that volunteered for this week's shifts and announced the groups with hotline coverage in the coming weeks.

Meeting list – Alan announced that there have been 10 changes so far to the November 2005 meeting list. So far 10 unregistered groups have contacted SIA to confirm their meeting information. Postcards will be sent to all registered Suffolk groups to confirm meeting days/times and contact info. IF information is correct, the cards still need to be returned with the group's contact information. Alan explained the procedure for the Corrections and Change form. Any Corrections and Changes must have a group contact and phone number. Also, any Corrections and Changes must have supporting documentation (i.e. it must be written, not just called in). John asked if those meetings that have been confirmed could be denoted in the meeting list. Alan will work on this. Marylou suggested using a boldface type. Marylou asked about temporary changes. It was suggested that any change greater than 4 months should have a Correction and Change form.

Brian reminded those present that next month the committee chairs need to be re-elected. The requirements and descriptions are found in the By-Laws.

Third Legacy – Ed had a 2-hour workshop on sponsorship and another workshop on speaking at non-AA meetings. He has also conducted service workshops at area groups before their scheduled business meetings. Ed can be reached at 271-7546.

Literature – Kim reports that sales have been great!

Bulletin – E was introduced as the new Bulletin editor. She will be working mostly from home, as it is hard for her to get to meetings and would like to someone to share the commitment with her.

Institutions – Joe pointed out page 3 of the Bulletin and open institution commitments. He explained that the commitment at the Northport VA has been filled. He announced he will be rotating out of this job, but all information is computerized for the next person.

Archives – Bob presented a Bill W. bobble head with a Santa hat. He reminded everyone that archives can be fun! He brought the portable history of Suffolk AA to the meeting and is asking groups to submit histories photos (of locations, no people) and a new history project of a favorite story about people's groups.

Public Info – Rick received one letter from an assisted outpatient program looking for a 12 and 12, Big Book and Reflections. He has been working on PSAs for Newsday and the radio stations. Pennysaver "offered" to sell us space for a PSA and it was raised that it would be in conflict with the Eleventh Tradition. Rick is continuing to work on the Open Meeting list and the anonymity statement for the newspaper.

Share a Thon – Richard is looking for volunteers to view the films "AA - Rap with Us" and "Young People In AA". He is looking for reviews and critiques of the films for SENY. He announced that the Al-Anon "Choices" will be on March 25 and that 16 groups are needed to host workshops.

Ad Hoc Committee on Technology - John reported there was nothing to report.

**GSO** - Tim talked about his commitment bringing the LINKS to SIA and taking the Bulletins to GSO. He asked for any other material that needs to be brought to GSO.

Old Business: None

New Business: Fred talked about the 2<sup>nd</sup> of 2 treasury reports distributed. The second has budget adjustments due to some committees going over budget and others costing less than anticipated. A motion to approve the adjusted budget was <u>PASSED</u>. Also, \$219. was donated to SIA from the Institutions Committee.

Elections - A motion was **PASSED** to name Bob R. Archivist, as it is a non-rotating position.

It was <u>PASSED</u> that the current rule requiring someone seeking office in SIA to be present for the election would not be enforced for Cathy (Corresponding Secretary) who could not be present.

The following slate was presented and PASSED:

Alternate Chair – Alan S.
Treasurer – Jon H.
Recording Secretary – Robyn G.
Corresponding Secretary – Cathy S.

The new officers will take effect in January 1, 2006. Committee chair people will be elected at our next meeting, next month in <u>Riverhead</u>.

Michelle volunteered to bring the milk and coffee to our January meeting, next month, in Riverhead.

Meeting closed at 9:10 PM
