From the Chair -

I know that everyone belongs to the "best group in the whole world" and you enthusiastically want to announce it to the world. Some even have their meeting schedule listed in other area meeting lists so everyone can attend. I would like to ask those that do list their groups meeting schedule in other areas or lists to exercise some restraint when doing so. The problem is not so much in listing the meeting, but in making changes or removing the listing when the group goes out of business or changes something, like where they meet, days, times, etc.

As an example, the New York City Intergroup (www.nyintergroup.org/meetinglist/) will take a listing from anyone from any group from anyplace in New York, New Jersey or Connecticut and list the group in their meeting list. They have over 60 Suffolk County meetings listed and about 60% of the meetings that are listed are non-existent or incorrect. This means that anyone looking for a meeting in Suffolk County using NY Intergroups meeting list has less than a 50/50 chance of finding a meeting.

Now comes the alky part – They won't unlist or change a meeting based on someone saying the info is incorrect. When I asked to have the non-existent meetings removed I was told that only the person that originally listed the meeting or a group member can change it by sending in a form. Some of these groups were listed as far back as 1988 and have been out of business for almost as long so finding those group members that belonged to those nonexistent meetings is a problem. I would bet that some groups don't even know that their group is listed on the NY Intergroup meeting list.

If you are one of those that was (hint), or could have been, if only for a day, (hint) a member of the nonexistent group, please download and print the form from - nyintergroup.org/groupinfo.cfm and send it in or I will send you a form to get your old meeting removed or updated.

Our assuming the responsibility for the future of A.A. starts in our home groups and the way we elect our trusted servants. It's all about delegation.

"Concept I establishes the "final responsibility and ultimate authority" of the A.A. groups; but, in actual practise, how are they to manage A.A.'s service affairs? By *delegation*, Concept II declares." *
