Concept Three

As a traditional means of creating and maintaining a clearly defined working relation between the groups, the Conference, the A.A. General Service Board and its several service corporations, staffs, committees and executives, and of thus insuring their effective leadership, it is here suggested that we endow each of these elements of world service with a traditional "Right of Decision."

Tradition Three

The only requirement for A.A. membership is a desire to stop drinking.

We always speak of taking a Group Inventory using the Twelve Traditions – we can also apply the Twelve Traditions to ourselves....

- 1. In my mind, do I prejudge some new A.A. members as losers?
- 2. Is there some kind of alcoholic whom I privately do not want in my A.A. group?
- 3. Do I set myself up as a judge of whether a newcomer is sincere or phony?
- 4. Do I let language, religion (or lack of it), race, education, age, or other such things interfere with my carrying the message?
- 5. Am I overly impressed by a celebrity? By a doctor, a clergyman, an ex convict? Or can I just treat this new member simply and naturally as one more sick human, like the rest of us?
- 6. When someone turns up at A.A. needing information or help (even if he can't ask for it aloud), does it really matter to me what he does for a living? Where he lives? What his domestic arrangements are? Whether he had been to A.A. before? What his other problems are?

"Our membership ought to include all who suffer from alcoholism. Hence, we may refuse none who wish to recover. Nor ought our membership ever depend upon money or conformity. Any two or three gathered for sobriety may call themselves a group in our program, provided that, as a group, they have no other affiliation." *

Tradition Three defines the personal liberty of the A.A. member. It says, in effect, that any alcoholic can be an A.A. member the moment he says so. Neither can any of us deprive him of that membership, no matter what his behavior. Perhaps no other society has staked out such a broad expanse of liberty for the individual as this. Every A.A. newcomer feels at once that he is wanted and trusted and loved. How well we understand his needs; certainly we have had them ourselves. Seldom has any alcoholic taken unfair advantage of that unlimited charter for freedom. We took this decision for individual freedom years ago. We are glad that we did; there has never been any cause for regret.
