Tradition IV Checklist

- 1. Do I insist that there are only a few right ways of doing things in A.A.?
- 2. Does my group always consider the welfare of the rest of A.A.? Of nearby groups? Of loners in Alaska? Of Internationalists miles from port? Of a group in Rome or El Salvadore?
- 3. Do I put down other members' behavior when it is different from mine or do I learn from it?
- 4. Do I always bear in mind that, to those outsiders who know I am in A.A., I may to some extent represent our entire Fellowship?
- 5. Am I willing to help a newcomer go to any lengths his lengths, not mine to stay sober?
- 6. Do I share my knowledge of A.A. tools with other members who may not have heard of them?

Tradition IV

"With respect to its own affairs, each A.A. Group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take action that might greatly affect A.A. as a whole without conferring with the trustees of the General Service Board. On such issues our common welfare is paramount."

This Tradition is a specific application of general principles already outlined in Traditions I & II. The first sentence of Tradition IV guarantees each A.A. group local autonomy. With respect to its own affairs, the group may make any decisions and adopt any attitudes that it likes. The founders gave every group the right to be wrong, providing that the sole objective is sobriety. They knew that alcoholics didn't like rules. In Tradition IV of the 12 & 12, it quotes rule 62: "Don't take yourself too damn seriously." No over-all or intergroup authority should challenge this primary privilege. We feel this ought to be so, even though the group might sometimes act with complete indifference to our tradition. We are sure that each group can be granted, and safely so, these most extreme privileges. We know that the familiar process of trial and error would summarily eliminate any radical departures from A.A. tradition.

An A.A. group need not be coerced by any human government over and above its own members. Their own experience, plus A.A. opinion in surrounding groups, plus God's prompting in their group conscience would be sufficient. Yet please note one important qualification. It will be seen that such extreme liberty of thought and action applies only to the group's own affairs. Obviously, If any individual, group or regional committee could take an action which might affect the welfare of A.A. as a whole, or seriously disturb surrounding groups, that would not be liberty at all. It would be sheer license; it would be anarchy, not democracy. Therefore, we A.A.s have universally adopted the principle of consultation.

There is a line between group conscience and plain old group lethargy. A lot of groups refuse to take a turn answering the Hotline phones. Others do not have a conscientious Group Service Representative or Intergroup representative. It's sad, because there is such joy in service. Chief Justice Warren was quoted about a law they were reviewing: "I know that it is legal, but is it right?" The same principle could apply to our autonomous groups that do not participate in the 1st Tradition, i.e., "---our common welfare should come first, personal recovery depends upon A.A. unity."

Concept IV

Throughout our Conference structure we ought to maintain at all responsible levels a traditional "Right of Participation," taking care that each classification or group of our world servants shall be allowed a voting representation in reasonable proportion to the responsibility that each must discharge.
