#### MY GROWTH IN SPIRITUALITY

About six years ago, I was in terrible turmoil. I had blamed God for my troubles, past and present, because He allowed them to happen. At least that was what I was thinking. One day I decided that I could not deal with life anymore. Suicide was the only answer, so I thought. I gave God an ultimatum. Either he come and save me or I would end my life. Before I could succeed at the deed, he came to me in a very special way. As I pressed a gun to my chest, I closed my eyes as I squeezed the trigger. Before that moment, the only thing on my mind was the emotional pain I was feeling. Then, all of a sudden, my mind was filled with the image of my grand daughter's face. It snapped me back to my senses and I knew that God had not forsaken me. Shortly thereafter, I heard a man speak at a meeting. He seemed to glow when he spoke of God in his life. His spirituality and the happiness and peace that came along with it could not be denied. After much thought and reflection, I approached my sponsor and told him that I wanted to ask that man to be my sponsor. He asked me why. I answered, "because of his spirituality." So, this man agreed to be my sponsor. I started the steps with this man and realized I was having a real problem with step three. You see, I had stayed "dry" for twenty four years. My ego told me that I didn't need God to help me stay sober. After all I had done it myself for all those years. Sure, I had God back in my life, but on my terms. Every time I had a problem I went to God for the solution. Most times I didn't find the solution because I wasn't open to him. I wasn't listening for his answers to my prayers. I couldn't accept the fact that God works through other people. I couldn't see that the answer to my prayers were right in front of me. I was looking right through them like they were not even there. I did not have an open heart. I wasn't totally surrendering. When I thought my prayers were going unanswered I isolated. I crawled into bed. I lost myself in the TV set. I spent hours on the computer. I was miserable. I was using my own free will. I was not looking for or asking for his plan for me. I did not ask Him to show me "His will." Every time I took back my will I wound up isolating. I missed meetings. I didn't make phone calls. One day my sponsor asked, "How is that working out for you?" The answer was, "It's not." He told me to start my day with the Third Step Prayer.

"God, I offer myself to thee - to build with me and do with me as Thou wilt.

Relieve me of the bondage of self, that I may better do Thy will. Take away my difficulties, that victory over them may bear witness to those I would help of Thy Power, Thy Love and Thy Way of Life. May I do Thy Will always!"

Over the past six years something wonderful has happened to me. I have found peace and serenity. Oh, I have my bad days but I reach out to friends and deal with it. God put these people in my life and I have the awareness to hear His message through them. My sponsor introduced me to some Spiritual rock bands. This music has become a big part of my sobriety. My sponsor and support group is "priceless." Whether you know it or not, something you share at a meeting may be just what a person needs to deal with a crisis. In the past ten months, I have gone through being served with divorce papers after thirty nine years of marriage, my brother being in a coma after bypass surgery, a daughter with thyroid cancer, another daughter being arrested. You know what? I can still smile. I can still be grateful for what I have and what God has given me. I pray daily. I stay "God conscious" with music. I attend a prayer group life is simple and I am happy and at peace.

This Concept differs in the fact that it talks about the "other" internal structure of our fellowship. This includes but is not limited to: non-trustee members of the trustees' committees, the non-trustee directors of the two operating boards and the executives and staff members. They not only support the leadership of the trustees but they share the leadership with them.

This is the second longest of the Concepts so I can't even come close to giving you all the details in this short article but it covers all the various standing committees and their functions. A good read, especially the part on finance. It really lays out self-support. It describes the status of executives, how we compensate our paid workers, why we rotate and the principal of participation as covered in a previous Concept.
