Here are just a few interesting facts about Alcoholics Anonymous that happened throughout history during the month of November:

- 1895, November 26 Bill W. was born in East Dorsett, Vermont.
- 1934, November Ebby T. carries message to Bill.
- 1937, November Bill and Dr. Bob compare notes in Akron. Count forty cases staying sober.
- 1939, November 21 AAs in San Francisco hold 1st California A.A. meeting in the Clift Hotel.
- 1939, November/December Akron group withdraws from association with Oxford Group.
- 1940, November 10 First A.A. group formed in Minneapolis, Minnesota.
- 1940, November 12 First A.A. meeting is held in Boston, Massachusetts.
- 1940, November 14 Alcoholic Foundation publishes first A.A. Bulletin.
- 1941, November First Mass A.A. Meeting in Oklahoma City, 8 present, 1 was drunk.
- 1946, November 18 First Dublin, Ireland group met.
- 1947, November 1 First A.A. group in Anchorage, Alaska.
- 1950, November 16 Dr. Bob died.
- 1963, November 1 Reverend Sam Shoemaker dies.
- 1966, November 9 President Johnson appoints Marty M. to the 1<sup>st</sup> National Advisory Committee on Alcoholism.
- 1986, November Big Book was published in paperback.

# From the Archives - This history and others like it can be viewed at <a href="www.suffolkaaarchives.com">www.suffolkaaarchives.com</a>. ORIENT STEP GROUP, Congregational Church, 23045 Main Road, Orient

The Orient Group owes its existence to Hurricane Gloria in 1985. A longtime A.A., M.L., was in danger of being flooded out of her waterfront home and sought refuge at the local Congregational Church's parsonage. While waiting out the storm, she told her pastor of her history. He pleaded with her to start an A.A. meeting in the church.

She was reluctant to "talk it up" in her home community for anonymity reasons and so enlisted Herbert H., from nearby Cutchogue, to be the group's designated organizer. He showed up after a call from her and brought with him a sponsee, Donald, and Jack W., who was rehabbing a house in the next town.

These four held the first meeting of the Orient group in November 1985 in the basement of the Congregational Church. The basement, or undercroft, was also used for a playschool and, as the group grew larger, A.A.'s sometimes found themselves seats on the tiny chairs from the school.

After a year, Herbert left Long Island for a business venture in Tennessee, and Donald, now trained as a chef, left for Colorado, where he died tragically in an auto crash. M.L.moved away, then returned with a new husband, also a program member.

Meanwhile, the group gained members and stability with its one meeting, a step on Monday mornings. Jim. H. arrived in 1991 assumed, the coffeemaker and treasurer's roles, and has been doing them ever since. Around 1992, some members organized a second meeting, a Big Book on Friday mornings. Jim H. said, "I now have a meeting to get myself through the week and another to get myself through the weekend."

In 1996, a parishioner died in an auto crash, and the church decided to erect a new building in her memory. It also served to remedy the overcrowding and scheduling problems due to the expansion of A.A. and the playschool. The Orient group now meets twice a week in a building tailor made to its purposes.

Besides its regulars, Orient is host, when they are in town, to A.A.'s from Sweden, San Francisco and Vermont, as well as a large contingent of vacationers and second home owners. Perhaps our most unusual occurrence was when Big Matt, now a regular, arrived with a proof of attendance slip from the California Department of Probation.

### Alcoholics Anonymous' Alkathons Explained

Many alcoholics and other individuals in recovery often have a hard time coping with the winter holiday season. With Thanksgiving, Christmas, Chanukah and New Years traditionally being holidays that are celebrated with large amounts of drinking by many people, some recovering alcoholics tend to become a little bit anxious and squirrely around this time of the year. Fortunately, many Alcoholics Anonymous groups across America hold events each year that are known as Alkathons. What are Alkathons, you might ask. These events, which take their name from the word marathon, are actually AA meeting marathons, wherein basically non - stop Alcoholics Anonymous meetings are held in a designated location for a specified period of time.

The reasons why recovering alcoholics often do not cope well with the holiday season are fairly easy to understand. Please let me offer my own case in point. Although I am a member of Alcoholics Anonymous and have been sober for almost 11 years, I still get a little uptight around the winter holiday season. For many years, when the holidays rolled around, I would stock up on alcoholic beverages and the amount of my drinking would increase. At family get - togethers and other holiday social occasions, I would do just fine, as long as there was a large supply of beer or other alcoholic beverages on hand. Now being sober, I no longer have the option of drinking my way through the winter holiday season.

Enter Alcoholics Anonymous' Alkathons. These events are designed for people just like me, who might be struggling with making it through the holiday season. At AA Alkathons, participants can avail themselves of the benefits offered by attending several different types of AA meeting formats in one location. Additionally, participants at Alcoholics Anonymous' Alkathons can bask in the camaraderie and companionship offered by other members of the AA Fellowship, who can empathize with how they feel.

No matter how long a person has been sober, Alcoholics Anonymous' Alkathons are always beneficial. The support network that is present at these events is often crucial to many people in recovery. Every recovering alcoholic is only one drink away from their next drink and the holiday season frequently tests the sobriety of many of them. The steady format of AA meeting after AA meeting at these Alkathons means that at any time during a specified time period, usually 24 hours, anyone who desires to participate can do so. Whether it be for one 1 hour meeting, or to stay the entire 24 hours, Alcoholics Anonymous' Alkathons are designed to meet the needs of every person who seeks the services of the event.
