From the Archives - This history and others like it can be viewed at www.suffolkaaarchives.com. MELVILLE GROUP, King of Kings Lutheran Church, 2601 New York Avenue, Melville

According to co-founder Ray, the original people responsible for getting this group up and running were Tony Z., Mary U., and Jim J., most of whom were from the Huntington Group. There were no meetings on a Saturday evening and this group was created to fill that void. The only Saturday night meeting in the immediate area was in East Northport. The Melville Group started in 1982.

The format decided upon was novel at that time. The focus of the meeting would be the Alcoholics Anonymous magazine The Grapevine. Ray believed there were no other meetings like this to be found in Suffolk County at the time. The group would use the current issue of the Grapevine and the leader would pick an article from that issue — so every meeting had its own different topic each week. Every Grapevine has a theme each month which made it easier for the speaker. The articles are usually very short and to the point which also made it easier. After the leader reads a paragraph the reading continues around the room. After the speaker shares it is open up for others to share also.

Tony Z. was a member of King of Kings Lutheran Church and spoke to the pastor about using the church for a meeting. They had a bet that if Tony beat the pastor at golf, he could start the meeting there. Since the group meets at the church, it's fair to see who won the golf game although the meeting would have probably met there anyway.

The church board, however, was a bit apprehensive about letting the meeting start. "We also had a member on the board" who, while keeping his anonymity, helped tip the vote in favor of the group; "he was our secret weapon".

The group first started on Saturday night and within six months added a Monday night meeting. Then they branched out to two meetings on Tuesday night. For quite a while there was a core of 5 or 6 people attending the meeting as others would come and go. But over time beginners came in and adopted the group. So as they say, the rest is history.

In 2009, they added a young people's meetings on Saturday. Young people in the group were looking for a place to socialize and bring other young A.A. people in the area. "We definitely recognized the need...and it has been very successful".

The Melville Group meeting room has a nice collection of handmade signs, each of which has its own story. The sign that seems to be a favorite of the group says "It just keeps getting better". It came from a newspaper advertisement for Jaguar (the car) and "we just decided to hang it up because we liked the saying". Another sign made by co-founder Tony got a little ragged over the years and has since been laminated. There is a collection of slogan signs donated by Mary U. who has become a legend of sorts in the Huntington area. She helped many people over the years stay sober and although she has since passed away, she will always be known affectionately as Black Mary.
