#### DOG HOUSE GROUP

VFW Post 8300, 330 N. Dunton Avenue, East Patchogue, NY

Early in 1997 three men, Bobbie E., Ray K., and Vince M., saw the need for another A.A. group.

We had noticed that at many meetings where folks read that some folks had difficulty with some of the words used in the Big Book and Twelve and Twelve. We also noticed that at discussion groups, people only had one chance to share.

After much deliberation we decided on the meeting format and the name for the new group. The name decided upon was DOG House, or God spelled backwards. We wanted the name as the program is founded on a spiritual basis. Also, we wanted the discussion topic to be random, chosen by our Higher Power and not based on anyone's favorite topic.

To accomplish this we would use the book "As Bill Sees It" to find a topic. We also felt that it would get folks more comfortable using the Big Book and 12 and 12. The random part would be selecting topics using poker chips. The page numbers in "As Bill Sees It" that referenced articles in the Big Book or the Twelve and Twelve would be written on poker chips. The topic would be based on the chip selected. We provided several copies of all three books so that everyone could read the topic and see which book it came from. The meeting Chairperson qualified by saying he or she was an alcoholic. No "drunkalog" was wanted. We encouraged folks to talk about what the topic means to them no matter how much time they had in the program.

During his time going to meetings, Vince M. started writing down words folk were having difficulty with along with book title and page number. Other members were invited to do the same. In short order we had 150 words. These words were put in a basket. At the beginning of the meeting two words were selected. The words were looked up in the appropriate books and a dictionary. The purpose was to discover the meaning of the word as used in the text. We felt this would lead to a better understanding of the program. Business meetings during the first year were very informal. It was decided that anyone present at the meeting was a group member. Any problems encountered would be brought up at meetings, discussed and resolved to become part of the Group Conscience. In 2000, the group felt it was large enough to have a "regular" business meeting. The same policy held - if you came to the meeting you were a group member and could vote on any issues brought up. The Chairperson of the Business meeting would be the meeting Chairperson. A secretary, treasurer, and literature person were selected.

In 2000, the decision was made to start a beginners meeting. We sent for the appropriate literature and decided to stick as close to that outline as possible. Old timers who attended the beginners meeting have told us that we were running the meetings as General Services recommended and were probably the only beginners meeting running that way.

Current trusted servants are: Hugh M. - Chairperson GSO, John C. - Treasurer, Lynn S. - Secretary, Gene - Grapevine (also SIA), Joe C. - Literature. *Vince M., 2006, SIA*

The GSO Guidelines for Archives, commonly referred to as the "yellow sheets" provides a basic outline for local archive committees to begin their own archive collections. The Scope of the Collection is a vital component for developing an archive collection that is reflective of the local area and also continues to support our primary purpose of carrying the AA message through the archive collection. Over the next few meetings, I am hopeful that the committee will come up with a group conscience on what the scope of the SIA Archives will collect.

Additionally, the other vital component to a collection is the preservation of the material that is collected. The GSO has also put out guidelines on preservation (not in the yellow sheet format) which I will discuss in a later article. In preparation for this vital work that we need to be doing as a committee, there will be a Preservation Workshop during the May Archive meeting on the 4<sup>th</sup> Wednesday of the month, May 23, 2012 at 7pm at the SIA Office. If you are interested in Archives, or in learning how to protect and preserve your vital documents for the future, come down to the SIA Office. Please note that the time is one hour earlier than the normal Archive meeting. We look forward to seeing you!

#### **SIA Hotline Request**

Many of the numbers that we are using for our 12 Step Volunteer list to accept calls from the Hotline are inoperative numbers.

At the present time our books have over 2,500 names. Many have been carried over for too long and need to be corrected. We will be sending each group new sign-up papers with the monthly SIA mailing. District Captains will be bringing them to groups when they go to fill out sign-up sheets for assigned weeks also.

Last year many groups either didn't mail them back in time or at all. This year we are starting over with ONLY the lists sent back to the office.

If the new book has only 200 numbers than those are the numbers we will use. It is important that the groups mail them or fax them *no later than June 25th*. Our intent is to print the new lists in July with an early August distribution.
