Central Islip 12 steps Of Peace

St. John of God Church, 84 Carleton Avenue, Central Islip

"My name is Donald S. I am 38 years sober and one of the co-founders of the Central Islip Twelve Steps of Peace Group. We started the group on the 4th of July, 1976 out of resentment with another group. The original founders were Donald S., John M., Regina K., Ray S., and Jimmy F. The split was over money and whether or not to have separate accounts for anniversaries. A big howdy do took place and as they say 'If you don't like what you hear in one place, leave, buy a new coffee pot and start a new group'.

This I did. I was nine years sober. I went to my local church in Central Islip, St. John of God, on Carlton Avenue and spoke to the priest. We got one night a week on a Wednesday, for a closed meeting. It grew and more and more people attended. They gave us a small house of prayer meeting room. Many people came. We asked for another night and we got Friday. Wednesday was step meetings. We read, passed the book, shared and then questions for the speaker.

I had a dream where my higher power, which I call God, led me to The Twelve Steps of Peace group. I didn't say anything to nobody at the meeting. At an early group business meeting we were throwing out names and I threw out The Twelve Steps of Peace. Everyone liked it and it was voted in.

We had a variety of people in the group; policemen, firemen and working men. Friday nights we had an open meeting which was really well attended. It was the days of smoking and the best job in the place was cleaning the ash trays. We paid our rent. They wanted to give it to us for nothing but in the traditions we have to pay and we did.

There are many guys in that group that are still sober and sober a long time. They're spread out all over the place. There's one fellow up in Rochester, NY. He started a couple of groups up there (John M.)

We had a tradition to give to the newcomer a 12 and 12 and a Big Book to start him off and if he didn't have the money, that was ok as long as he came to the next meeting and if he has the money, throw it in the basket. He could pay when he could. If he never paid that was ok, too. That worked out pretty well. I was treasurer of the group at the start. The money poured in and doubled in my drawer. We bought literature and donated to Intergroup. We spent about \$2000.00 a year on literature. Most people come back and paid for the books we originally gave them free. There was no financial problem at all. We paid the rent. We had plenty of money to do everything. We elected a literature man. It really started to be a really nice group. The great thing about it was all the donations; wives baked cakes, people gave coffee, someone else the milk. We didn't even have to buy that stuff!

Now, it is smaller and still open one night a week. There were a lot of rehabs that opened half-way houses and a lot of fellows came from there. They didn't have funds and there was trouble paying the rent. There are only a few people left now in the group."
