FROM THE ARCHIVES CHAIR

The Archive Committee has been busy the last few months. We have completed cleaning the cabinets in the archive room and found many wonderful items! Some items have been placed in files for digitization and others are in binders in order to be compiled into one larger file. There were over 15 black and white 8x10 photographs that were found that we framed and placed on display in the SIA. Over the next month or two, we plan to catalogue and then display a number of books of interest that we found. One of the books we found was a 1st edition 12 Steps and 12 Traditions and a little book that was a pre-cursor to the As Bill Sees It that is now out of print and may be very rare. By the time you read this article, I will have attended the National A. A. Archives Workshop and have learned how to best preserve these two very rare and valuable books and whether they should be placed "out" on display or not. What I do know now, is that I will be creating a display for the Share-A-Thon with pictures of many of the items that have been uncovered so that you can see what the Archive Committee has been working on.

Recently, I was asked a few questions from A.A. members that, honestly, I did not have the answers for. I contacted Michelle M., the GSO Archivist and she graciously answered the two questions. The first was to determine whether a member's book had been signed by Bill Wilson (probably not) and the other was to determine how many 3rd edition books were printed during each printing (the list is long- contact me for the answer!). I was also asked by Pete, our Literature Chair, anything about the 2nd edition Big Book that SIA purchased several years ago. Yes, I do! In our fire proof file cabinets is the 2nd edition, 1942 Big Book signed by Bill Wilson. WOW! Thank you Pete for the question! I also received from Fred and Connie S. a 1974 meeting list in fabulous condition for our archives. Thank you both so much!

This week, Bob R., the SIA Archivist for over 10 years, formally rotated out of his position. His service to SIA and to the Archive Committee speaks for itself. The volumes of group histories that are in the SIA Office are a testament to the decade of passion and effort that Bob gave to preserving Suffolk County A.A. histories. Please join me and the SIA Archive Committee in wishing Bob well in any future endeavor he takes on or committee he chooses to serve with.

Finally, the Archive Committee has changed the day and time of the meeting. Please join us at the SIA Office on the 1st **Wednesday of the month from 7:00-8:30pm** for an evening of history and fellowship. If you or a sponsee need a commitment but don't have a lot of time, this is a great commitment because it is one time month for 90 minutes working with people who love A.A. and history and have a desire to give something back to the program.

Center Moriches Sunrise Sobriety

St. John the Evangelist RC Church, 25 S. Ocean Ave., Center Moriches

During the early months of 1990, there were a few A.A. members in the Moriches to Westhampton area who were looking for an early morning meeting. In July 1990, Sandy S. & John M. secured the use of a room in the Lutheran Church on the Bypass in East Moriches. The first meeting was held on a Tuesday morning at 6:45am. The meeting was named "Sunrise Sobriety" and as no one volunteered for the coffee commitment, it was decided to make the meeting a BYOC.

Attendance was small but consistent and members asked for another morning meeting. Group conscience added Thursday's to the meeting list. Thursday became a Step meeting except the first Thursday, at which a Tradition is read and discussed.

In 1993, the Lutheran Church made plans to use the meeting room for a children's pre-school and Sunrise Sobriety was looking for a new morning home. The "Red Barn" at the St. John's Roman Catholic Church in Center Moriches was made available.

In early 1994, group conscience decided to expand to 5 mornings per week with anniversaries to be celebrated on the last Friday of each month. (A side note: Because of the cost of purchasing shades with the 12 steps and 12 traditions printed, a member hand wrote the 12 steps and 12 traditions on "butcher paper" and they are still being used today.)

During 1995, 1996, 1997, 1998 and 1999 the group continued to grow. During that time, a "Reflections" meeting on Tuesday, a Saturday morning meeting and a Sunday "Big Book" meeting, was added. As the new millennium began, the growth of the group continued with especially large attendance on the weekends. Group Conscience added a Tuesday evening meeting and a second Sunday morning "Men's" meeting. Also, anniversaries could be celebrated on Sundays.

In early 2000, discussions were held on celebrating our 10th Anniversary with a get together in July. A committee of Laura M. and Mark C. provided a wonderful catered breakfast that was enjoyed by all members present and our guests.

Group conscience then decided that every 10 years the group (Sunrise Sobriety) will have a large celebration and every even numbered year we will celebrate in the month of July with bagels, donuts and coffee.

In early 2006 a group inventory was taken. Through 4 short business meetings group conscience was re-identified and added where necessary.

The group continues to grow.
