

Recently at the exchange meeting when I asked some group representative what happened, his speakers never showed up for their last commitment. He looked at me calmly and said "Yeah we have a reputation for that." I was dumbfounded. It was like a badge of honor. That is the way I used to act, an irresponsible person that no one could count on to follow through on any plans I made. I would hope in recovery we would have moved past that.

#### Amagansett A.M. St. Michael's Lutheran Church 486 Montauk Highway, Amagansett Sun – Fri 7:30 a.m. Sat – 8:30 a.m.

This group was formed by Anthony, who had been raised in Amagansett but attended morning meetings at the Mustard Seed in midtown Manhattan. He liked the concept of starting the day with a meeting, and wanted to make a morning meeting available in Amagansett on the East End. His plan was ambitious - a "sunrise" meeting, six days a week, with a variety of structures. His vision was motivated by his general commitment to maintain his sobriety by advancing our primary purpose, his desire to give back to his community specifically, and to hopefully attract his mother, who still lived, sick and suffering, in Amagansett.

The minister of the church across the street from Anthony's house had reached out to Anthony before he got sober. After Anthony got sober, he enlisted the minister's help once again, to lend support in launching the meeting. The minister generously offered him the Parish Hall.

Although regrettably, Anthony's mother never walked through the door, the meeting was a great success. The core people at the beginning included Claire, Carol, Lolia, Mike, Arnold and David. There were about ten people there consistently every morning. Within a year, the meeting grew to thirty to forty people, even in the winter. In the summer, attendance was up to sixty people during the week and on Saturdays, up to a hundred people. Today, Amagansett A.M. offers an As Bill Sees It meeting, a Promises meeting, a Step study, a Big Book study, a Beginners/Sponsor meeting and an Open Discussion, and meets every day. Although Anthony relocated to Connecticut in 2001, he still has a strong emotional connection to the meeting and was kind enough to impart its history over the phone from Connecticut to an Archives Committee member.

#### FROM THE ARCHIVES CHAIR

The SIA Archive Committee has been very busy throughout January and February. To date, the entire Bulletin collection has been catalogued. Our next step with the Bulletins will be to determine what is already digitized and copy those files to a specific archive file.

We have also catalogued the entire set of Suffolk County meeting lists in our possession from 1974 to the present. Again, we will determine how many of these are already in digital form and then scan those that are not. This will be a more difficult process only because some of these lists are in fragile condition.

In addition to these projects, we started a Flyer Binder project. This is a binder that will document the history of the events that have been undertaken by SIA for AA's in Suffolk County. These include flyers for the Share-a-Thon over the years, Third Legacy Workshops, SIA Special Events etc. Currently, our binder is limited. So if any of you have a flyer that you can contribute or will allow us to copy for the binder, we would greatly appreciate it. You can bring them to the SIA meeting or drop the flyers off at the SIA Office and let the office know it's for Archives.

Finally, we are still working on interviewing long-timers. This project was discussed last year and is still being worked on. We will update you further as the project proceeds.
