

#### Motion to Amend Suffolk Intergroup Association By-Laws

Purpose; to align the Archives Committee with the other committees, having one vote and full accountability to the group reps. and the fellowship as a whole.

1.) Page 11 Section N. Paragraph 3.

Change the first sentence, leave the second sentence as is, and remove the rest.

#### Currently reads:

3. Recognizing that the preservation of archival material requires both experience and training, the Archives committee may appoint an Archivist who would be exempt from the two-year rotation. The Archivist is a non-policy making, non-authority position. The committee retains final responsibility and authority for the use of the archives, and exercises its group conscience in regard to matters of general policy.

- Page 5, Section 4-A Paragraph 3. Include Archivist in the list of appointments. Currently reads:

#### FROM THE ARCHIVES CHAIR

April Bulletin Article

March was a very busy month for the SIA Archive Committee. I am extremely grateful to the committee members for the extra effort that they put in throughout the month in order to meet the various commitments that we, as a committee, had. Without the committee member's dedication, it would have been impossible to complete so many of the tasks we were presented with.

On March 3<sup>rd</sup>, committee members brought a small display of SIA Archives to the Unity Breakfast that included old Bulletins and the GSO folio of old newspaper articles. They also took the names and numbers of people with over 30 years of sobriety in order to sign the 30 Year Sobriety Big Book. We'd like to thank Linda C., the Unity Breakfast Chair and Bob R. the SGS Archive Chair for inviting us to bring a display to the breakfast.

For the first time ever, the SIA Archive Committee was invited to bring their archives to the SENY Area 49 Convention in Tarrytown on March 23<sup>rd</sup> to display along with the area archives. Creating a display for this exciting event dominated our March meeting. This display included archive materials from SIA that spanned the decades 1970-2010, including Suffolk County Meeting Lists, Bulletins, and Share-A-Thon programs. In addition, the encapsulated cards and photos from Nell Wing were placed in a binder and brought to the convention. Once again, the committee would like to thank Kathy K. SENY Convention Chair and Roberto, SENY Archive Chair, for inviting us to display the SIA Archives at the convention.

While preparing these displays was a priority for the month of March, there were several other activities going on in Archives. Our first long-timer's interview was conducted by a friend of the Archive Committee and is in the process of being transcribed. We listened to this wonderful interview during our meeting and learned so much about how SIA first began back in 1973. It is our hope to create a history of the origins of SIA using this and other long-timer's interviews to commemorate SIA's 40<sup>th</sup> Anniversary later this year. Another committee member has taken on the difficult and time consuming task of proof reading and editing our group histories as well as checking to insure their accuracy for meeting times, days and locations. This is an ongoing process that is expected to take several months. Finally, while considering items for the displays, it became known to the committee that the portable group map that was created for last year's Unity Breakfast was not in the office. Sandy B. contributed this map to the SIA Archives and we have now stored it in a safe location in the SIA Office and will be able to use it for upcoming events.



Nuts and Bolts Group Cross of Christ Lutheran Church 576 Deer Park Avenue, Babylon

The Babylon Nuts and Bolts Group is an offshoot of the original Deer Park Group, which met in the same location. It evolved from a segment of the Deer Park Group that wanted to incorporate "outside" literature, include cross-addicted people and utilize an open format.

Steve S. and Hank B. were two of the founders of the Nuts and Bolts Group. The name "Nuts and Bolts" was chosen over candidates "Cut the Crap" and "Back to Basics." On January 13, 1989, there were 13 members. The first meeting was step meeting, which ran for 90 minutes. The founders of the group also attended Deer Park Group meetings when their group wasn't in session.

The major stumbling block for the new group was the occasional loss of its meeting room, due to holidays and church functions. When that occurred, the members would wait outside and steer alcoholics who appeared to other meetings in the area, especially the Deer Park Group. A classroom in the school attached to St. Cyril's Church was used, followed by a basement in the convent next door. After three years, the group moved to its present location at the Cross of Christ Lutheran Church in Babylon Village. In addition to the Friday night step meeting, a beginners' meeting was formed and held on Sundays. Presently, there are still occasional meeting place problems, but in furtherance of both the group's tradition and the twelfth step, the group members continue to direct alcoholics to other area meetings, so that they will not miss a meeting due to temporary displacement of the Nuts and Bolts Group.
