a: power to influence or command thought, opinion, or behavior

b: freedom granted by one in authority

Having run through all the Traditions last year, this month starts a series of articles about Intergroup itself.

Recently, a number of people have been asking, "Where does Intergroup get the authority to tell the groups what they must do?" The answer is simple: Intergroup has no such authority and doesn't claim to have it. Neither has Intergroup the authority to tell any individual member of AA what he or she should do, nor does Intergroup claim such authority. Where, then, does the power of Intergroup to make decisions arise and who do these decisions affect?

According to the SIA by-laws, "The Suffolk Intergroup Association of Alcoholics Anonymous is a service organization available to all AA Groups in Suffolk County, whether they contribute to its support or not" and "The primary purpose of this Association shall be to assist Alcoholics Anonymous Groups in Suffolk County in their common purpose of carrying the AA message to the still suffering alcoholic by performing those functions which the individual Groups cannot accomplish alone." Intergroup is an organization the members of which are not individual AA members, but AA groups. These groups have joined together to perform certain functions. When the representatives of SIA's member groups meet at the monthly business meeting, the decisions they make affect only the operation of Intergroup. Even Intergroup's member groups, in the running of their group affairs, are not bound by the reps' decisions. Where, then does Intergroup get the authority to do anything? From its member groups. Each AA group could, under the Tradition of autonomy, run its own hotline. Such a situation would be confusing and inefficient, and few groups would have the necessary resources to do so, but they could try if they wanted to and, in fact, in the early days of Intergroup, there were independent "answering services". Rather than endure such a chaotic situation, Intergroup's member groups empowered Intergroup to act for them to create and maintain a hot line. The member groups then set the rules under which SIA would manage the hot line for them. The member groups continue to set the rules today.

Who, you might ask, the hell cares? Like so many things, questions about what Intergroup is and what its proper functions are resurface every so often. Recently, this question arose with regard to the meeting list and what groups will be included in it. Some people have said that Intergroup does not have the authority to require individual groups to submit group meeting information to the Intergroup office; these people are correct. How fortunate, then, that no one at Intergroup claimed such authority. What the reps did decide was that the meeting list that the groups have empowered and required Intergroup to publish would include among its listings only those groups for which Intergroup was in possession of current meeting times, days and locations.

As the Twelve and Twelve says, the difference between a request and a demand is plain to anyone. In this case, the difference between a demand for information and a statement of what the organization has decided to do should be equally plain.

What if a group decides it doesn't want to send its meeting information? Then it is deciding that it doesn't want to be included in the meeting list, a decision it has every right to make. Should such a group expect Intergroup to change the rules to accommodate the group? No, it should not. Part of getting sober is growing up. Adults accept the consequences of their actions and do not expect the world to change to accommodate their individual whim.


So does Intergroup have the authority to force compliance from individuals or groups? No. Does Intergroup have the authority and the responsibility to set conditions on the services it provides to the groups, especially where not to set such conditions would be deleterious to the purposes of the service? Yes. Is Intergroup obligated to ameliorate the effects on some groups of the groups' own bad choices? No. You can take someone's choices away as much by forcing what you think is right on them as by forcing what you think is wrong.

## Group History of the Month

The Wading River Group, which now meets at the North Shore Methodist Church, didn't start there. It started meeting in a Sunday school classroom above St. John's Hall on Wading River Road in August of 1981. I was lucky enough to be one of the A.A.s responsible for its formation. At the time, I was the coffee maker of the original Shoreham group which used to meet twice a week at St. Marks R.C. Church on Randall Road. A named Charlie C. and I had talked it over with our sponsors as well as with our many friends in the Shoreham group. We wanted to add a local beginners meeting as well as an open discussion which, at that time, Shoreham didn't offer. We felt as long as we weren't in direct competition with our mother group it would be OK. I remember the afternoon that Charlie and I approached the Pastor of St. John's, Fr. Damm. He at first seemed surprised and even taken aback by our request. He tugged at his chin for a moment, studying the floor. Then he smiled and asked when we would meet. "Sunday and Thursday evenings", we said, and eagerly added that it would not interfere with any of his church activities. And further, that we would certainly clean up after ourselves and be glad to make a small donation each month from whatever money might be left over from our coffee expenses. He agreed to give us a chance for a trial period of one month and the rest, as they say, is history. Thinking back now I recall the first A.A. meeting I ever attended. The first thing I noticed was the 12 and 12 shades. After that the table off to the side with books and copies of the Grapevine, a freestanding pamphlet holder, and framed slogans hanging above. Inside an adjoining kitchen there was a large coffee urn and on each table there were ashtrays and

## The First Step

Alcohol was my power. It was how I managed. It was my guiding force, what I looked forward to as a reward after a long week – before I started drinking during the week, as my weekends lengthened. Alcohol gave me eloquence, real or imagined, that I lacked when I wasn't drinking. I looked good in the mirror. I was smart. I had great ideas. I knew everything, could solve the world's problems. I worked hard and played hard.

I was living life like a Jekyll and Hyde. When I was away on business I drank every night. It was great. I was free. So what if I suffered hangovers. By the time evening came around I was up again. When I came back from business I tried to live clean, and I succeeded for a while. Eventually my drinking merged with ordinary life. My weekends lengthened. I didn't want to look at myself in the mirror. I hated myself and self loathing took over.

I knew for years I was an alcoholic. I knew I was losing control. I was pretending. I knew I was powerless. I couldn't make it without a drink. I didn't care if I lived or died. Yet my life was still manageable. I was able to work. I exercised like crazy. I prayed. I kept my drinking at home. But the façade was cracking.

I started coming to AA meetings. For a year and a half I was aloof. I listened but stayed quiet. I read the Big Book, the 12x12. I drank. The men and women who wrote their stories for the Big Book I could relate too. I pleaded with God to help me. All I really cared about was drinking. Life had no meaning. One night, so sick, so tired, so alone – after my husband removed all alcohol from the house – I lay in my bed and promised to give up my job, to do anything to stop drinking. I was wiped out. That was a Tuesday.

On Wednesday afternoon I went to a meeting and someone spoke to me. Really, I think that was the second time

of course the room was filled with folding chairs. It didn't occur to me then but somehow all this stuff had to be obtained and that of course was the next step that Charlie and I would have to take. The Shoreham group was generous. As coffee maker I also set up and was aware that they had an old set of shades that weren't needed anymore so I started with them. They really were destined for the garbage because they wouldn't roll up anymore and the edges were all torn. So I cut off the wood, trimmed them up, and glued them to two large sheets of plywood and edged them with duct tape.

I fashioned a group name sign from a piece of shaved tree bark and wood burned the name "Wading River" along with the date. There was an interesting knot on the wood which I used as the circle of fellowship and I inscribed the A.A. triangle inside it.

in all the time I was coming to meetings that someone spoke to me. I had yet to raise my hand and declare myself an alcoholic. The fellow who spoke to me recommended a Thursday night meeting. I'd never noticed it in the meeting list before. Strange.

On Wednesday night I went to a meeting and raised my hand, said my name, and declared before all I was an alcoholic. It was the kind of meeting where everyone has the chance to share (almost always) so I was sort of sharing by default. On Thursday afternoon someone at a meeting offered me a cup of tea. I was so grateful but refused because I was shaking so much I could barely stay on the chair.

On Thursday night a miracle occurred for me at what is now my home group, and I started to become We. I added my name and my voice to all the fellows past and present who are the We of the first step. I was We, no longer alone. Over the days and months that followed, now two and a half years later, I realized that the isolated trying for sobriety was never going to work. I needed to become We and I'm very glad to be a part of a fellowship of men and women who share their experience strength and hope with each other. That's how we stay sober after taking the first step.
