Many changes are to correct grammar and spelling and some others will help to clarify some of the policies that have already been approved such as minor changes to the wording to reflect electronic banking. We will have presented the updated document to the SIA reps at the October business meeting. Copies will be distributed at the October business meeting along with a summary sheet for your group to review. ## Notes on Proposed Changes to the SIA Bylaws

<u>PAGE</u>	<u>Description</u>
Inside cover	Preface to the Group Conscience Book: Addition. The Group Conscience Book is meant to contain policy decisions that don't rise to the level of Bylaws changes, but it's useless if nobody knows it exists.
p. 2, art. IV	Section 2.B: Remove duplicate text. Originally "The Chairperson, Alternate Chairperson and Treasurer shall have a minimum of five (5) years of continuous and current sobriety. The Recording Secretary and Corresponding Secretary shall have a minimum of two (5) years of continuous and current sobriety. The Recording Secretary and Corresponding Secretary shall have a minimum of two (2) years of continuous and current sobriety."
	Section 4.A.5: Modified to reflect change in banking procedures. Formerly "Shall be an authorized co-signer of checks."
p. 3, art. IV	Section 4.B.3: Modified to reflect change in banking procedures. Formerly "Shall be an authorized co-signer of checks."
	Section 4.B.5: Modified to reflect changes in committee status and to agree with Article VI, Section 1, Paragraph G. Formerly "Shall function as chairman of the two ad hoc committees: the Bylaws Committee and the Special Needs Committee."
	Section 4.C.1: Modified to reflect changes in banking procedures. Formerly "Shall receive all funds and deposit them in a bank designated by the Groups."
	Section 4.C.2: Modified to reflect change in banking procedures. Formerly "Shall be an authorized co-signer of checks."
	Section 4.C.5: Modified to reflect changes in committee status and to agree with Article VI, Section 1, Paragraph G. Formerly "Shall be a member, but not the chairperson, of the Finance Committee."
p. 4, art. V	Section 3: Phrase "Committee Chair" changed to "Nominating Committee Chair" for clarity.
	Section 5: Modified for clarity. Original phrasing specified that officers' terms ended when their successors were <u>elected</u> . This was changed to reflect that officers' terms end when their successors assume office <u>after their election</u> .
p. 5, art. VI	Section 1.E, Title: Name of "Institutions Committee" changed to "Treatment Facilities" to reflect the fact that the committee no longer serves correctional facilities.
p. 9, art. VIII	Section 4: Underline removed from phrase "one and only one".
p. 9, art. IX	Title: Changed from "Special Meetings" to "Meetings"
p. 9, art. IX	Section 2.B: Changed to clarify the intent of the paragraph. Of the officers (5), the committee chairs (14), the office manager and the SGS liaison (2), for a total of 21 people, a majority (11 people) must be present.
p. 10, art. X	Section 2: Remove "the Webmaster" as that position is now a committee chair.
p.11	Printing information: Update to present.
Appendix C	Suffolk Intergroup Association Website Guidelines: #1. Remove duplicated words "be used".
	Suffolk Intergroup Association Website Guidelines: #11. Change "and SENY" to "SENY and other Area 49 intergroups" to reflect current standards.

### **Group History of the Month**

#### COPIAGUE PINELAWN GROUP

The Copiague Pinelawn Group which meets at the Copiague Christian Church on the corner of Pinelawn Avenue and Abbington in Copiague began eleven years ago when about eight of us met at Nina J.'s home.

At one time the Copiague Evening Group met at this church but moved to Our Lady of the Assumption Church where they had once been. When they moved the Copiague Christian Church stopped permitting A.A. from using its basement. Several years later a new congregation took over the use of the church and one of the members was in A.A. The church became available, again. The member was a friend of Nina's and told her a group was welcome.

Those of us who started it were members of the evening group but we thought a Tuesday meeting (that's when we meet) would be nice. We did not leave the evening group although most of us have either moved away or left. We began with a topic meeting but later dropped that and now have a simple closed meeting.

We had some rough going at first. The only space available was a classroom in the basement, which could not

### PATCHOGUE EAST LOVE & SERVICE

In 1978, a representative from Brookhaven Hospital contacted the S.I.A. office and asked to have a meeting started in the hospital to accommodate the patients as well as people in the community. Four women volunteered, a woman named Agnes, Fran H., Linda, and Peggy. Their first meeting took place on a Saturday night in May, 1978. Held in a downstairs conference room with access to the outside, it began at 8:00 PM and ended when the last person shared. In the beginning the meeting was sparse - just a coffee maker and someone to open. By 1982, things had changed and there was enough interest to expand to three meetings per week, Friday and Saturday nights and Sunday afternoon.

Eventually, we held business meetings and became a group. We participate in all aspects of recovery in Suffolk County. We book commitments at the speaker exchange, and have representatives at S.I.A., G.S.O., and Share-athon.

Our group also chairs three meetings at Seafield Center, one at Talbot House, and two others at the psychiatric center at Brookhaven Hospital.

Note – In early 2015, the group relocated to Our Lady of Mt. Carmel Church. They meet there at 8:00 PM on Wednesday (CD), Friday (S/T), and Saturday (OD).


## Subscriptions to Nassau Newsletter On-Line
