Greenport Crossing Borders St. Agnes Church School Front St. at 6th Ave., Greenport Tuesday 7:00 PM Open Discussion

This open discussion meeting was begun in October, 2006 by Pauline W. The reason she created it was to serve a unique situation. In the winter months, St. Agnes Church opens a room for the homeless to be fed and to sleep. The people are bused from Riverhead by an organization that transports the homeless to different towns each night in the wintertime. Pauline thought it would be nice to have a meeting at the church should any of the homeless feel they needed it.

From the start, the group has been averaging about 12 people, ranging from 8 to 15 people per night. Some of these individuals came from the homeless shelter located the next room over. The meeting evolved from the winter to year round. Right after it started in October of 2006 they submitted paperwork to have it listed on the Suffolk meeting list but for some reason it was never published. They resubmitted the information in January of this year and are now listed for the first time in the March 2008 schedule. They are

hoping that with the influx of summer people this year the group may grow during summer months.

Pauline is involved with both the homeless shelter and the A.A. meeting. She told me that Father Tom, the priest at this church, was very receptive to opening up the school building at night for the homeless and very receptive to Pauline starting the A.A. meeting at night.

It was a wonderful experience to go Greenport to photograph the meeting room and get the history of the group for the Suffolk County A.A. Archives.

I met very dedicated people working in the homeless shelter plus dedicated people who started the meeting to help anyone who wished to come. On a lighter note, I was asked to be the speaker for that night. This is the first meeting that I have ever noticed and tasted Starbucks coffee being served.

# "Man plans......God Laughs

"I'm a recovered alcoholic. My name is J.J. I wasn't content when at nine I asked my father when I could drink and smoke like him. I was told when I could pay for them like he did. A short time later I got a paper route. I was made to turn the money to the house as we were poor. I never got a penny. I turned to stealing. If you took from me I took from you to even things up.

A few years later when I got a beating I prayed to God that the "perfect church" taught me that if I was in the right He would protect me. The beatings got worse, especially when he was drunk.

God didn't protect me, God had abandoned me again, so that God didn't abandon me, but rather I abandoned I abandoned God. If you hurt me, I hurt you to even things up. that God didn't abandon me, but rather I abandoned the God who carried me through all the good and ba things in my life. Again, I had become more importa

My behaviors and attitudes led me into to many jails and eventually into a few prisons. Later, followed by a series of visits to psych wards, institutions of higher learning if you will. God's will sucked. The God I was raised with, in that church, never protected me or answered my prayers, even though I continued to pray. I hated God more than He hated me. If you hated me I hated you more just to even things up.

AA later taught me that these were "foxhole prayers" I came into AA with an intact belief system, my hatred of God and mankind in general.

I did in AA what I did in life. I'm a loner and I didn't mix well with people at that time. So, I got involved with the "91 YPAA at Stony Brook University. I loved it. A year later I started a Unity Day Breakfast with a committee of six friends for three years until AA decided to start one also so I ended the one I started as my goal had been achieved.

During this time a friend, Jimmy G., and I were riding home from Smithtown and we stopped so he could make a phone call. In the time he took to call home I made a deal to buy cabinets and showcases at a store. I told Jimmy that I just decided to open a recovery so we went to Bayshore where I picked one out. I had that store from 1993 to 2006 when I sold it.

I say these things not to brag, but rather to show you the power of the new relationship I developed with my God. All the the time I did these things I prayed for guidance and help to do them. Never realizing that I was praying to the God that I had hated so much and trusting Him to guide me through these new adventures.

During this time I heard about a Big Book that people who had 30 years could sign and, again my restlessness and discontent kicked in as they were easily awoken at times. I wanted to sign that damn book. It gained a measure of importance to me overnight. I knew that, having the time I did that I'd make 30 years.

Then I started to get sick. I had three hip replacements within 14 months. A year later I had a major heart attack resulting in a triple bypass. They told me that it left me with a high risk of a fatal attack if I didn't change my lifestyle. Again, I felt abandoned by God in my time of need. I felt myself obsessing over that damn Big Book again. Then five months ago I was told I have stage 4 cancer and it's not curable. They gave me 6 months to a year to live. Again God screwed me. I'd never get to sign that damn book.

What did I do wrong? Nothing!!! I did nothing wrong. Sometimes bad things happen to good people. I can see that God didn't abandon me, but rather I abandoned the God who carried me through all the good and bad things in my life. Again, I had become more important than the God of my understanding that AA had given to me years ago. I had forgotten my new mantra. "If it's good it's of God, if it's not good it's not of God". I must always give prominence to the 12the step where it says "to practice these principles in all our affairs" Practice, practice, practice...look out Carnegie Hall, here I come.

My priorities are straight again. I am preparing myself for my next journey as I approach the end of this leg of my journey.

The damn Big Book no longer controls my focus. I'm back in the day, thank you God. The book hasn't lost it's significance, only it's importance in my life. I'll probably sign it when the comes and maybe not. I am in the only book that really matters to me today. I'm in the book of life. My story was written millions of years ago in this book. Just like AA taught me almost 30 years ago, I just have to suit up and show up.

I'm aware enough of my character defects and my shortcomings to know that I need a new sponsor. My sponsor, Mike Flemming, just passed away and I know he wants me to get another one.

I feel like I'm going to make it to 30 years, but if I don't it's okay. Because I'm busy working on this relationship with my creator on a daily basis and I'm in great hands. I'm back to doing what I have to do and not obsessing on what I want to do. I need to honor my God, after all I need to try to even things up, knowing I'll fall way short.

Thank you Alcoholics Anonymous for all you have taught me and continue to teach me on a daily basis. I have written this not to boast but rather to remind me that I have evolved into a child of God as I was told by my sponsor Paul White almost 30 years ago. I remain indebted to Alcoholics Anonymous and God. I'm eternally grateful to both.
